1.1. GENERAL INFORMATIONS ABOUT THE COMPETITION

The competition will be part of the Austrian Wakeboard Cup and carried out as a **4-Star CWWC** event with **600 World Ranking Points and prize money**. (Total amount and money split will follow in Bulletin 2)
 Moreover there is the chance to win two **Wildcards for Red Bull Wake of Steel** on June 16th, 2012 in Linz / Upper Austria. Therefore we will honour the best obstacle performances during the day.

1.2. ABOUT VIENNA

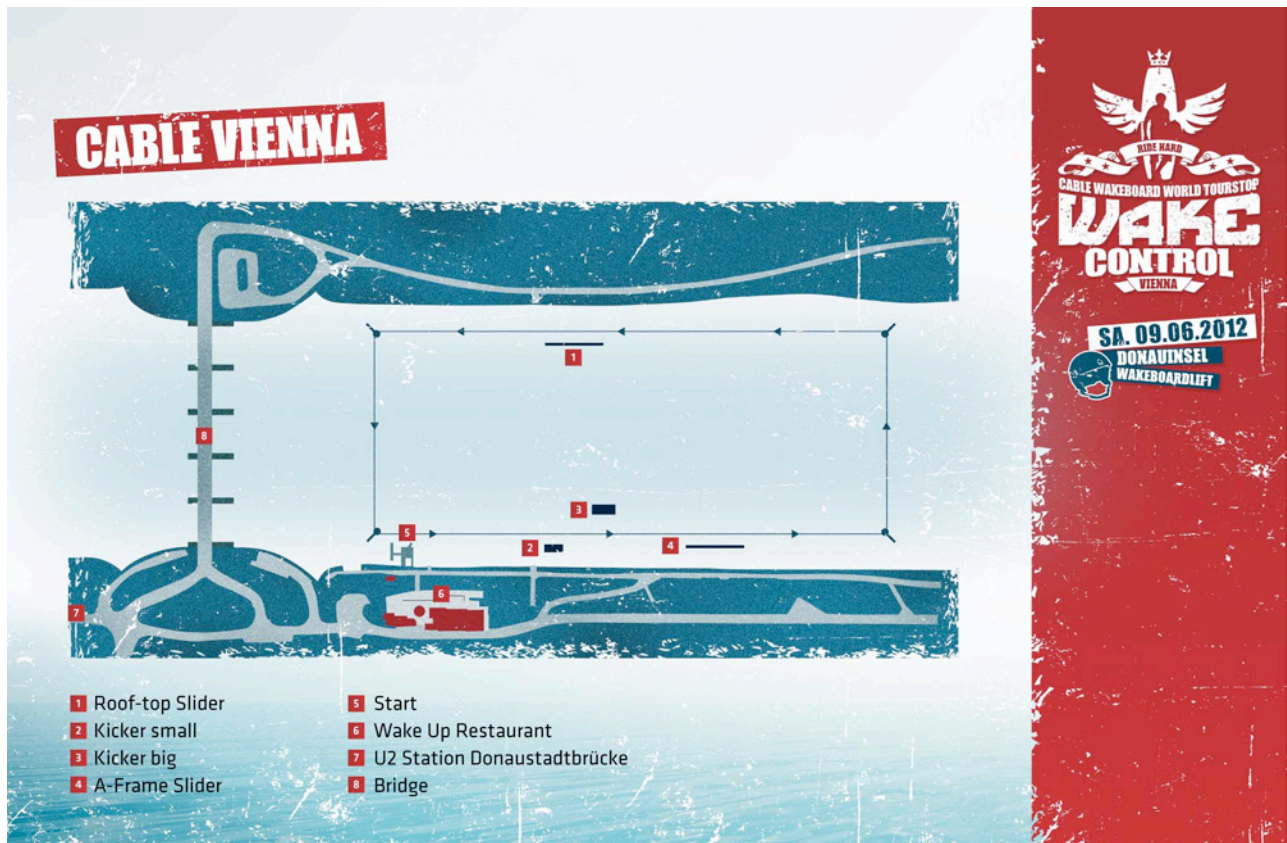
Vienna is the capital city of Austria and located in the east of the country. With more than 1,7 Million inhabitants it's the biggest city in Austria, well known for its culture and sight seeing.

By the way: **Vienna is chosen the most worth living city in the world** for three times in a row!!!

2. SETUP

- Cable:** Rixen 4 Mast System, length: 832 m, height: 10,0 m
 The cables height was increased in 2010 and has a very good pull now.
- Obstacles:** Kicker small outside
 Kicker big inside
 Shape Obstacles Rooftop Slider inside
 Shape Obstacle A-Frame (Fetzy Mini-Shred Series) outside



3. ENTRY REQUIREMENTS

- 3.1. Rules:** The competition will be held in accordance to the IWWF Cable Wakeboard World Council rulebook 2012. You will find a full copy at www.cablewakeboard.net
- 3.2. Registration:** Please create your own profile on <http://www.cablewakeboard.net> and join the event. There will be a maximum of 70 riders on first come first serve principle. A limit of 20 riders per nation is fixed to ensure as many different countries as possible. **Riders must be registered latest till Monday, June 4th 2012.** For registrations later then June 4th you have to pay a penalty fee of 50%.
- On Site Registration: Friday, June 8th 2012 from 4 – 6 pm central European Times!**
Don't forget to bring your passport or ID as well as a copy of your license with you.
- 3.3. Categories:** **Junior Ladies/ Junior Men:** 1993 or later
Open Ladies / Open Men: Open class, no age restrictions
Masters: 1981 or before
- 3.4. Qualification:** The competition is open for national and international athletes. All riders should be current member of their respective country's IWWF affiliated Federation. In addition, entrants from EAME should have the EAME International Wakeboard License. (National Federations register their rider's license online).
- 3.5. Entry Fee:** The entry fee is € 60, - per competitor.
You have to pay the Entry fee and complete all required registration paperwork at the **on site registration on Friday, June 8th 2012 from 4 – 6 pm CET!**
- 3.6. Safety** All riders must wear an approved life vest and a helmet in the course at all times. All participants ride/ take part at their own risk.

7. HOW TO GET THERE

You need to have a current identity card if you are in the European Community. Otherwise you need a passport.

7.1. Public transport

If you use the public transport you best go by train to the main stations in the city center. Then take the Underground U2 and leave the train at Station "Donaustadtbrücke". Use the back end exit of the station. Then turn right and after 300 Meter you reach the cable park.

7.2. by car

Coming from west, south and east use the A23 city highway.

Exit "Ölhafen Lobau"

Coming from the north use the A22 highway. Also take the Exit "Ölhafen Lobau"

Turn left at the first traffic light and follow the street back till you see the signs for "WakeUp" or Underground. For parking use the park & ride garage on the right hand side.

For € 3,- you can stay there the whole day!

Note: You need to buy a "Vignette" when you hit the border. The prize for 10 days is € 8,-

Speed limits: city: 50 km/h, country road: 100 km/h, highway: 130 km/h

7.3. by plane

“Vienna Schwechat international airport” is about 15 minutes away from the cable park. You can either use the CAT (city airport train) and then change to the underground or **send us an email with your flight details to office@wakecontrol.at till June 1st, 2012.**

Then we will try to arrange pick up service in groups.

As an alternative you can fly to Bratislava (Slovakia), about one hour from Vienna. Please note: there is no pick up service possible from Bratislava!!!

8. LIABILITY:

The organizer does not take over adhesion for persons -, special or financial damages opposite fighters, arbitrators, official ones, aids or third persons. All fighters participate in each relationship on own danger, even if they engage themselves outside of the match, e.g. in the master program. With the participation the runners do without any demands of requirements from all cases of damage, which result directly or indirectly from the meeting. All participants must be liability-insured accident - and/or. The requirements of the condition and the safety precautions of the match distances depend on the valid in each case regulations of the international water ski and wakeboard federation (IWWF) region EA, the national water ski federation (ÖWWV), the valid in each case regulation and delivering mode of the ÖWWV and the valid in each case agreement (product requirement specifications) between the organizing committee and the ÖWWV, whereby the arrangements of the respective arbitrator are determining. Each participant commits itself to speak own objections the arbitrator. With his start the fighter gives to recognize that the given condition of the match distance and existing safety precautions are suitable as and are sufficiently recognized. An adhesion for a certain condition of the competition distance or certain safety precautions, going beyond that, does not take over the organizer. All athletes get the adhesion explanation during the registration suburb to the signature submitted.
