1 GENERAL

- 1.1 **Applicability of the Rules:** The rules set forth herein govern wakeboard competitions sanctioned by the Cable Wakeboard World Council (CWWC). It is requested that Federations establish rules as close to these rules as possible. Whenever the masculine is used, the same shall be construed as meaning the feminine where the context so requires.
- 1.2 **Exceptions to the Rules:** Where compliance with the rules is not feasible, the Chief Judge shall with the approval of the majority of the Judges, make the necessary changes. Such changes will be announced at a riders' or team captains' meeting, and by posting. The Chief Judge shall send a report to the CWWC to explain these changes to the rules. Where the rules are definite and feasible, a vote of the Judges to decide whether to enforce any provision is prohibited.
- 1.3 **Drug Testing:** All competitors must agree to be subject to doping control. Specific policies and procedures regarding doping control shall be detailed in the Medical Regulations of the International Waterski & Wakeboard Federation.
- 1.4 **Unsportsmanlike Conduct:** Any rider (or his representative) or official whose conduct is deemed unsportsmanlike or whose conduct may cause discredit to the CWWC or the IWWF, either on or off the competition site, before, during, or after the competition, may be disqualified from all or part of the competition including completed events and/or be subject to a fine to be determined by the CWWC, by a two-thirds majority vote of the Judges. Any and all infractions can also be punishable by disqualification of the whole team.

Unsportsmanlike conduct includes, but is not limited to: use of vulgar language in public, public tantrums, not riding to fullest potential, failure to attend designated functions or events, consuming alcoholic beverages during the competition, competing under false pretences, concealing significant injuries or health problems.

2 SAFETY

- 2.1 All Competitions must have a CWWC Official present for the entire event who is in charge to supervise the safety measures.
- 2.2 The Chief Judge and CWWC Official will check the entire site to ensure the competition can be carried out as safe as possible, especially when the site is built only for the competition.
- 2.3 All riders must wear an approved life vest that will float a rider who is unconscious.
- 2.4 A first aid team must be on site for all CWWC-sanctioned competitions.
- 2.5 Rescue boat must be in a suitable position to assist injured riders.
- 2.5 All participants ride at their own risk; they are expected to pay attention to any potential site specific risks and to perform a routine within their abilities.

- 2.6 Helmets must be worn in the course at all times.
- 2.7 The Chief Judge must check all obstacles before the official training or nominate a suitable official to do this.
- 2.8 The competition organizer is responsible for any injuries as a result of the use of obstacles that are used in an event that would normally be available to the public.

3 ENTRY REQUIREMENTS FOR WORLD CHAMPIONSHIPS

- 3.1 **Rider Eligibility:** A Federation may select its team in any manner it desires; however, each team member must be a citizen or applying for citizenship of the country which the Federation represents. In case of doubt as to the nationality of a competitor, the Judges normally will refer to his passport. If a rider does not have a passport from the country he is representing, he must prove residence in the country for at least five years and membership in an affiliated club of the Federation. Each Federation shall certify that all members of its team meet these qualifications.
- 3.2 **Competition Entry:** A rider may compete in the World Championships as either a team representative or individual.
- 3.3 **Individual Entries:** Riders who are not part of a team may compete as individuals. An individual rider's entry must be submitted through his respective Federation. Federations will decide the criteria for an individual rider's entry. There is currently no restriction to the number of riders who enter the World Championships as individual competitors.

4 CATEGORIES / DIVISIONS

- 4.1 Competition entry will be strictly by age with the exception of the Open category.
- 4.2 There will be a minimum of 6 riders required to open a category, with the exception of Mini Boys, Mini Girls and Masters Ladies, where 4 riders of at least three different nationalities are required. The Organizer will inform all participating Federations as soon as feasibly possible if there are insufficient riders within a category.
- 4.3 The Cable Wakeboard World Council will ensure that all riders' passports are checked for verification of age.

4.4 Age Categories 2011

Mini Boys & Mini Girls: 2000 or later (Under 12)

Boys & Girls: 1996 or later (Under 16)

Junior Men & Junior Ladies: 1992 or later (Under 20)

Open Men & Open Ladies: No age restriction

Masters Men & Masters Ladies: 1980 or before (Over 30)

Veterans Men & Veterans Ladies: 1970 or before (Over 40)

To clarify: a rider born in 2000 can compete in Minis, Boys, Junior or Open categories, or a rider born in 1992 can compete in Juniors or Open, same for Master and Veterans – a rider born in 1968 can choose to compete in Veterans, Masters or Open.

- 4.5 Double starts at one competition are not allowed. Starting in one wakeboard and one wakeskate category at one competition is not considered as double start.

5 HEAT SYSTEM / RUNNING ORDER

- 5.1 Competitions will use a heat system.
- 5.2 In qualifying rounds, positions are determined by the competitor seeding, which is determined by the Ranking List. For those riders who are not ranked, their specific heat and running order will be determined randomly. The Chief Judge and Chief Scorer will check and adjust the start lists to ensure the heats are fair and balanced, considering nationalities, riders that switched categories or any other reasons.
- 5.3 The number of riders in each heat is dependent on the total number of riders entered. A percentage of the riders from each heat will then go through to the, semi-finals and finals.
- 5.4 The riders that didn't qualify will have the Last Chance Qualification (LCQ) round. The heats and starting order in the LCQ will be drawn from the qualification results.
- 5.5 If a rider fails to be on hand and ready to ride when the cable is prepared to start, the Dock Marshall may recommend his disqualification to the Chief Judge; however, the Dock Marshall may grant up to one additional minute of time for emergencies developing or discovered just prior to the rider's turn to ride. For case of damaged equipment see rule 9.5.
- 5.6 In the case where a rider has been disqualified or has been scratched, a one-minute delay shall be granted to the next rider in the starting order if he was not on the starting dock at the time of disqualification. If more than one rider has been disqualified or has scratched, the time allotted to the next rider shall be one minute for each rider disqualified or scratched.
- 5.7 An example of the heat system:

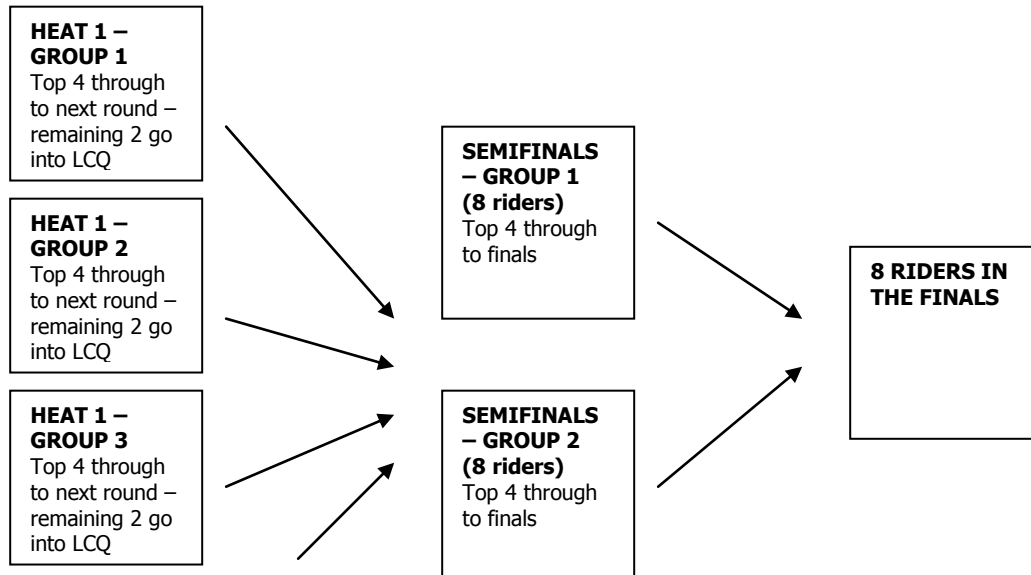

5.8 With the use of a joint position system, there will be instances where riders have finished in a different heat. Relevant placement will therefore be given to each individual, for example:

5.9 If feasible, in Semifinals and Finals, riders will in the 2nd run start in the reverse starting order according to the results from the first run.

6 COMPETITION AREA

- 6.1 The course will be marked by two visible buoys, the start buoy being approximately 150m before the second to last corner and the finish buoy approximately 150m after the drive tower. If conditions are appropriate, a kicker may also be used as the finish point on the course.
- 6.2 The buoy marking both start and finish lines must be underneath the running cable.
- 6.3 The course must be free of obstructions other than those specifically placed for the competition.
- 6.4 The judge’s station must be sited so as to have an unobstructed view of the entire course.
- 6.5 The site must meet CWWC safety standards.

7 TOW LINES

- 7.1 Only standard length lines provided by the site shall be used (not to be less than 17.80m) Standard length lines are that which are used for public and daily cableway use. Exceptions being the small cables (two towers systems) where the line length will depend on the site specifics and have to be approved by the Chief Judge.
- 7.2 Extensions and wider handles may be added by the riders. Shortening of the rope is **not permitted**.
- 7.3 In the interest of safety, extensions **may not** be added under the following conditions:
 - If additional length will bring riders into contact with solid or stationary objects,
 - If it would bring the rider into shallow water (~~less than 2 feet deep~~) within the competition area,
 - Be hazardous to spectators or themselves

- 7.4 The Chief Judge has the right to exclude extensions for any reason he deems is in the interest of safety.

8 OBSTACLES

- 8.1 All Obstacles in the course will be used at the rider's own risk.
- 8.2 There is no restriction on obstacles allowed in cable wakeboard world competition. The only requirement is that they be laid out so as to allow riders to safely perform an equal number of air tricks as obstacle tricks throughout the course. It is up to the Organizer and the Chief Judge to work together and decide on the best or most appropriate placement of obstacles, considering history, new trends, common sense and safety. However, the final decision rests with the Chief Judge.
- 8.3 For safety reasons, open water should be allowed for all air tricks. Obstacles shall not be placed in an area expected or forced to perform an air trick over an obstacle.
- 8.4 Riders will be judged on their equal use of both air tricks and obstacles.
- 8.5 If a rider falls in front of an obstacle he has to let go of the handle or he's disqualified.
- 8.6 The cableway management has to ensure that all obstacles used at the competition are safe. They must make all reasonable efforts to ensure that the obstacles do not damage riders' boards. However, the ultimate responsibility must lie with the riders.
- 8.7 All obstacles must have been in everyday use for a minimum of 14 days prior to the competition. When the site is built especially for the competition, the 14 days rule does not apply.
- 8.8 The Chief Judge will consult the present Council members to decide on the use and placement of the obstacles. The final decision rests with the Chief Judge, but the responsibility does not lie with him. In the interest of safety, the Chief Judge has the right to exclude obstacles for any reason he deems. Where during the training or the competition an obstacle is found to be defective, the organizer will make every effort to fix it as quickly as possible and inform riders of any potential problems with the obstacles. If an obstacle damaged during the competition can't be repaired quickly, it gets taken out and that heat must be restarted. A decision as to whether the obstacle gets put back later is for the Chief Judge in conjunction with the team captains. The position of the obstacles must not change between the official training and the actual competition.
- 8.9 The bulletin for the competition has to contain a drawing of the cableway with the height, distances between the pylons, description of the course, placement and specifications of obstacles noted. It must be published 30 days before the competition at the latest. The Chief Judge or a responsible Council member should be involved in developing the perfect placement of obstacles prior to distribution of the bulletin.

9 EQUIPMENT

- 9.1 **General:** All personal equipment is subject to the approval of the Chief Judge and CWWC Official.
- 9.2 **Boards:** Only wakeboards and wakeskates will be allowed. Both must float.
- 9.3 **Life Vest:** All competitors must wear a life vest. It is the responsibility of each rider to ensure their life vest meets the following specifications:
- It must float the rider
 - It must be constructed so as to provide adequate protection from impact damage to the ribs and internal organs.
- 9.4 **Helmets:** Riders must wear a suitable helmet in the wakeboard course. If a rider performs his routine without a helmet, he will be disqualified from the competition.
- 9.5 **Damaged Equipment:** A rider is fully responsible for his personal equipment. If a rider has damaged equipment when he's due to start, he will be granted max. **four** minutes to repair the equipment. The Chief Judge will have the final say as to whether the equipment has failed. The rider must have both feet back in his bindings before the 4 minutes elapses. Once the rider is on the water, if his/her equipment fails, he/she can't get a rerun (for example a ripped binding, broken board or a lost helmet).

10 FORMAT

- 10.1 Riders will be judged in a FREERIDE format only.
- 10.2 There will be a minimum of three rounds, a Qualification, LCQ, and a Final Round. The Semifinals will be run depending on numbers and time available. Every rider has two chances to qualify through to Semifinals or finals (in qualification and LCQ).
- 10.3 One round will consist of two runs (passes) through the course, each run consisting of combinations of inverts, grabs, rotational tricks, and obstacles. Riders may perform any tricks they choose in any order they wish. Only the best out of two runs will be scored.
- 10.4 If it is necessary to shorten the competition, the Chief Judge can decide to have only one Qualification Run. Especially if all riders proceed to finals and the qualifying run is used only to determine the final start order.
- 10.5 Judging of the routine begins when the rider enters the course and ends when the rider exits the course or falls.
- 10.6 There will be no Wild Card tricks in this format.
- 10.7 Sliders, Kickers, or other obstacles may be used.
- 10.8 Speed is at the discretion of the rider but must be within the maximum and minimum tolerances allowed for the site. The speed must remain constant while the rider is in the course. Exceptions being the small cables, where the cable slows down and accelerates automatically while rider is making a turn.

- 10.9 This format is obligatory for World Championships. The organizer and the judging team can decide on a different format for other national and international registered events (e.g. one out of the three or two out of three runs scoring, kicker contest, best invert contest, full round contest, half round contest, obstacles only etc.). In such cases the chief Judge together with Confederation or World Council has to apply the format and the judging criteria and they have to be published at least one month prior to the competition. Examples for these possible formats can be given by the IWWF.
- 10.10 For international competition at small/removable cable system the organizer has to submit the drawing of the pool/lake, obstacles and the cable to be confirmed by the relevant Confederation or World Council, no later than 3 months prior to the competition.

11 JUDGING CRITERIA / SCORING

- 11.1 Judging will be SUBJECTIVE only. There will be no predetermined points for any tricks and no attack sheets.
- 11.2 Points in the form of "style points" will be given and based on technical performance and impression.
- 11.3 The scores awarded will reflect each run (pass) with a single combined score from 0-100. Only the best of the two runs will be taken as a result. The lower scored run will be removed.
- 11.4 Each rider shall be allowed two runs through the wakeboard course during which time he may perform any routine he chooses. He will be judged on two subjective categories, to arrive at a single combined score for each run.

Riders are encouraged to perform a smooth flowing routine with a wide variety of tricks. Each maneuver should be executed as cleanly as possible and taken to its limit.

Scoring:

Judges will award a maximum of 100 points to each rider based on their overall impressions of each run performed. The judges will score each rider in the following categories:

Technical performance = 50 %

(Level and variety of tricks performed = what did the rider perform)

Judges look for the variety and diversity of tricks in a flowing creative sequence. In the judge's eyes, a better rider is one who throws a balanced variety of inverts, spins, heel side, toe side, switch, blind tricks, and handle passes etc, using both air tricks and obstacles.

Impression = 50 %

(Airtime, mastery, style and control of tricks = how did the rider perform)

How impressive was the routine, how big did the rider go? For Slider and Kicker: How controlled and balanced is the rider? The judges look for the degree of effort in each maneuver performed and of the overall run. Does the Rider show his personal style in the trick performed? Is the trick grabbed, boned, tweaked, shifted? Are the tricks landed clean? Good

body position in the air? How long was the trick grabbed? How good is the approach /cut of tricks, the flow in the run.

For each judge team a Head judge will be installed. After the first rider in the heat, the Head judge will give a range for the scoring of the first rider. This will give a solid base for judging of this particular heat.

Wild card

There will be no wild card in this format.

Calculation of scores:

The average method of calculating will be used. Scores from the two categories (Technical performance and Impression) of a rider's routine are added together to produce a judge's total score. All three judges' total scores are then averaged to produce a final score for a rider.

Judges should ensure that all scores given on the scoring sheets are scored out of 10. The necessary conversions will be made at the calculation stage to ensure that the above system is adhered to.

- 11.5 Repetition of tricks is not allowed during one run (rider can repeat tricks from the first run in his second run).
- 11.6 Any trick performed outside of the course or using the pull of a deflection pulley will NOT be scored.
- 11.7 There must be a minimum of three judges, one of which will act as Head Judge. All must be recognized by CWWC, or National Federation for national events.
- 11.8 Judges must ensure equal riding conditions are applied to all competitors.
- 11.9 The results may be displayed live during the competition, however, they're are not official until they're complete and approved by the Head Judge of the heat.
- 11.10 This judging criteria/scoring are obligatory for World Championships. Any changes to this judging/scoring system for an international competition must be approved by the relevant Confederation or World Council (see 10.9)

12 WAKESKATE

- 12.1 Wakeskate competitions will follow the identical format and rules as wakeboard with no dock start falls allowed.
- 12.2 Different formats can be applied as described under point 10.9 except for the World Championships.

13 TEAM SCORING AT THE WORLD CHAMPIONSHIPS

- 13.1 Federations must nominate their team riders immediately after the official practice.

- 13.2 It is encouraged to have a mixed participation with men and women riders within a team, although it is not compulsory.
- 13.3 Cable wakeboard & wakeskate team will comprise of a maximum of ~~12~~ **18** riders, with a maximum of **2** riders in the same category. The ~~6~~ **9** best scores will be used for country classification. In the event of a tie between 2 teams, the ~~7~~ **10** best scores will be used and so on.
- ~~13.4 Cable wakeskate team will comprise of a maximum of 8 riders, with a maximum of 2 riders in the same category. The 3 best scores will be used for country classification. In the event of a tie between 2 teams, the 4 best scores will be used and so on.~~
- 13.5 The system of awarding points for the Ranking list for World Championships (point 18.2) will be used for Team Scoring.

14 PROTESTS

- 14.1 Protests shall be made to the Chief Judge only by a team representative. Protests must be made in writing, must state the reason(s) for the protest, and must be filed as soon as possible, but no later than 10 minutes after the occurrence or 10 minutes after the results are announced.
- 14.2 Protests will only be allowed for non-compliance of the rules that may have had an adverse effect on a rider, not if you simply disagree with the results.
- 14.3 A correction of an error in the computation of scores is no grounds for a protest. If such an error occurs, it will be corrected as soon as possible.
- 14.4 Protests must be accompanied by the approximate equivalent in local currency of 50 EUR. This amount will be refunded if the protest is granted.
- 14.5 During your run, if you have any reason to request a rerun, you must stop performing any further tricks and raise your hand immediately. Please note, equipment failure as described in 9.5 is not a valid reason for a rerun.
- 14.6 Due to the subjective scoring nature and spirit of wakeboarding, video footage of any kind will not be used by Judges, riders or team representatives to resolve any disputes. Judges can only use the video footage before scoring a rider's routine.

15 SCHEDULE CHANGES

- 15.1 Changes in the schedule during the competition will only be made for adverse weather or water conditions, safety, or similar reason. Such changes will be announced at a riders' or team captains' meeting, and by posting.
- 15.2 The finals of each category must be completed to determine a winner, even if the Judges are obliged to continue them at a different site. If a final cannot be completed, all riders from the event will compete again where and when possible, until a winner is determined.

16 PRIZES AT THE WORLD CHAMPIONSHIPS

- 16.1 Medals or trophies will be awarded to the top three competitors in each category, with the exception of Mini Boys and Mini Girls.
- 16.2 Product prizes may be awarded in each division, at the discretion of sponsors.

17 OFFICIALS, JUDGES & SCORERS – CLASSIFICATION, ROLES & DUTIES

- 17.1 Officials are all CWWC or Confederation Council members and all persons working in the organization of the sport part for an event. They are nominated by CWWC or a Confederation Council and include: Chief Judge and Chief Scorer, judges, scorers, assistants, competition director, jetty marshals. At big events there are more officials with different tasks for coordination: registrations, doping control, cable security, obstacles, safety, TV production, team captains' coordinator etc.
- 17.2 ~~Judges and scorers~~ All officials achieve qualification levels by attending seminars and taking exams. CWWC and Confederation Council members are elected through IWWF procedures. ~~All other officials~~ Some Officials for big events are selected based on their area of expertise, experience in the sport and availability.

17.3 Officials qualification levels are *(1 star) to *****(6 stars):

17.4 The judges' and scorers' qualification levels are:

- National 2 — judge at the National Competitions
- National 1 — Chief judge at the National Competitions
- International 2 — judge at the International Competitions
- International 1 — Chief judge at the International Competitions

- 17.5 Organization of judging and scoring seminars is up to each Confederation. National Federations can grant levels National 2 and 1 up to ***** (3 stars)**. Levels International 2 and 1 **Higher levels** are in responsibility of the respective Confederation.
- 17.6 Progress can be made only one level at a time. In certain cases for outstanding candidates, exceptions can be allowed. However, never for International level 1 **levels higher than *** (3 stars)**.
- 17.7 **Reducing levels - for International level 2 and 1 **** and higher:** If a judge in the past two seasons hasn't judged at an international event or a national championship, or hasn't passed the official exam for the appropriate level, his level will be reduced by one.
- 17.8 Due to the fast development of the sport, all judges have to take part at one seminar in 4 years, regardless of the experience in the given period.

18 RANKING LISTS

- 18.1 CWWC Ranking lists are produced for all age categories. A rider can start in a higher category at any competition (double starts are not allowed) and he'll be awarded the appropriate number of points. Riders will be ranked only in the age categories where they earned points.

Ranking example: a Girl wins the international comp in the Open category and wins 500 points in Open ladies ranking. She also wins the Confederation champs in Girls, and 800 points in Girls ranking. So she's ranked in both Open Ladies and Girls, but in both age categories she only has the points she earned in that particular category: 500 in Open Ladies and 800 in Girls.

- 18.2 The points for the CWWC Ranking lists will be awarded for the following types of competitions with the system of awarding points as follows:

Placements are determined as described under point 0. In the occurrence of more categories of the same age and gender at the National Championships (e.g. Amateur Men & Pro Men), placements of advanced category are followed by the lower category. If a rider has dual citizenship, only one performance at National Champs counts, from the country he represents at titled events.

18.3 Basic requirements and limitations on number of events per country:

**CE International 4	2 events	to register with Confederation Council min. 1 month before the event, international judging panel, bulletin in English 1 month before the event, medals or trophies
*E & F national events	no limit	national judging panel

All events are published at event calendar at www.cablewakeboard.net, with online registrations for riders. All organizers have to deliver the complete start lists and results (including all qualifying, LCQ and semifinal rounds) to CWWC. International event organizers also have to deliver a press release in English with pictures from the podium within two days of the competition.

18.4 **CWWC World Rankings** will include competition types **A, B, BC, C, D, DC, CE** with 6 best results for every rider in every age category.

18.5 **CWWC National Rankings** will include all competition types with 6 best results for every rider in every age category.

- 18.6 Guest riders at National Championships and competitions E and F get no ranking points.
- 18.7 All ranking lists will be published at cablewakeboard.net.
- 18.8 **CWWC Annual World and National Rankings** are calculated for a calendar year (1 January till 31 December)
- 18.9 **CWWC Rolling World and National Rankings** are calculated for the period of last 12 months at any given date.
- 18.10 The expiration dates of the event results are as follows:

Worlds (A) and Confederation Champs (B) are valid until the next competition of a kind (this can be less than 12 months), or if the next competition wasn't held in the following 2 years, results expire on 31 December of that year.

Example 1: World Champs (A) were held in September 2008. As they're held biannually, next Worlds are scheduled for July 2010, so in this case results will be valid for 22 months (until the next competition of a kind).

Example 2: Confederation Champs (B) were held in October 2008 and in August 2009. When 2009 results were included, 2008 results expired even though it's been less than 12 months. Otherwise riders that took part at both Champs would be in big advantage until October when 12 months period expires. Same applies for the Worlds.

Example 3: Confederation Champs (B) were held in July 2008. In 2009 and in 2010 there were no Champs in that Confederation. Results expire on 31 December 2010.

National Champs (D) are valid until the next competition of a kind (this can be less than 12 months), or if the next competition wasn't held in the following year, results expire on 31 December of that year.

Example: National Champs (D) were held in September 2008. In 2009 there were no Nationals in that country. Results expire on 31 December 2009.

All other events - International (BC), (C), (DC) and (CE), and National (E) and (F) are valid for 12 months.
