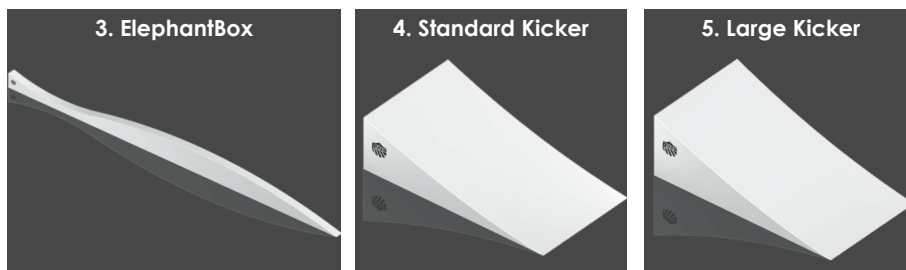
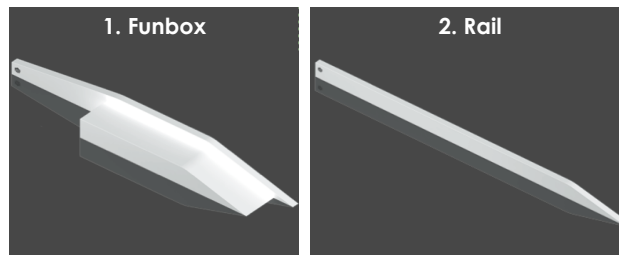
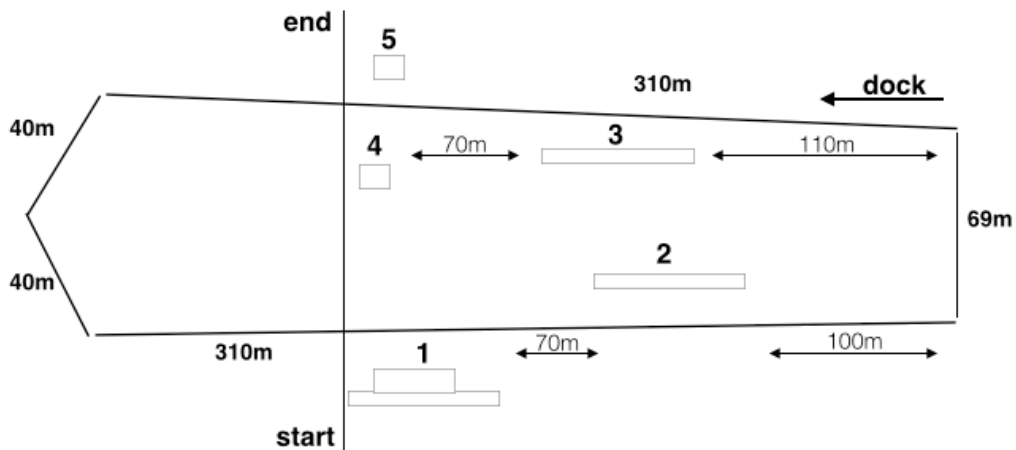
## Online Event Registration
